SECTION: 2. COMPOSITION / INFORMATION INGREDIENTS

Contents: ($\alpha + \beta$) Thujone, *a-pinene*, *b-pinene*, camphene, myrcene, limonene, 1,8-cineole, camphor, linalool, bornyl acetate and borneol.

SECTION: 3. HAZARDS IDENTIFICATION

Medical Information: May irritate skin or eyes. May cause respiratory tract irritation. May be harmful if swallowed.

SECTION: 6. ACCIDENTAL RELEASE MEASURES
