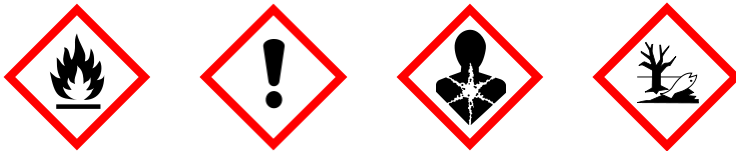

4. FIRST AID MEASURES**Eye contact**
