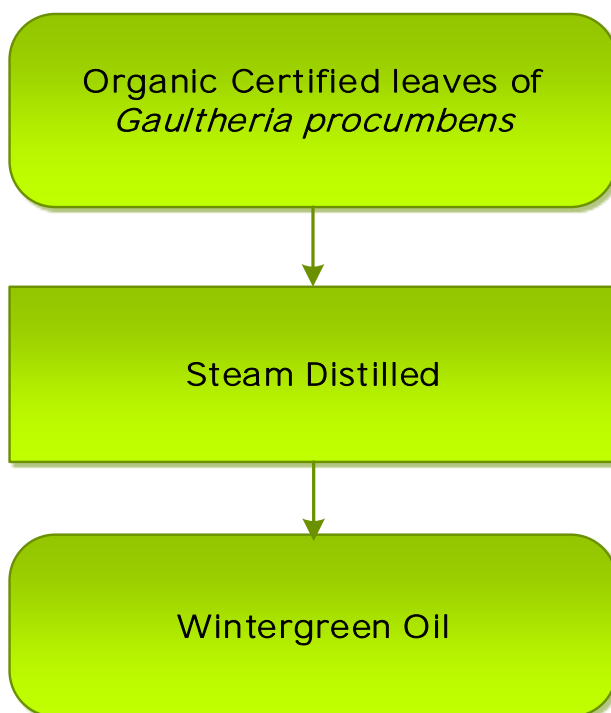

In the event of any dispute, the Customer hereby agrees that Jurisdiction is limited to the province of Ontario.
