#### **6. ACCIDENTAL RELEASE MEASURES**

## Personal precautions, protective equipment and emergency procedures.

Use personal protective equipment (see section 8). Avoid breathing vapours, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Beware of vapours accumulating to form explosive concentrations. Vapours can accumulate in low areas.

### **Environmental precautions**

Prevent further leakage or spillage if safe to do so. Do not let product enter drains. Discharge into the environment must be avoided. Inform the relevant authorities if the product has caused environmental pollution.

## Methods and materials for containment and cleaning up

Large spills: Pump as much liquid as possible with an explosion-proof pump or a hand pump. Absorb the remaining liquid with inert absorbent. Collect and seal in an appropriate container properly labelled for disposal.

Small spills: Absorb spilled liquid with inert absorbent. Collect and seal in an appropriate container properly labelled for disposal. Use only non-sparking tools.

### 7. HANDLING AND STORAGE

### **Precautions for safe handling**

No direct lighting. No smoking. Ensure prompt removal from eyes, skin and clothing. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Handle in accordance with good industrial hygiene and safety procedures.

# Conditions for safe storage, including any incompatibilities

Store in cool place. keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Keep away from sources of ignition. Protect from heat and direct sunlight. Normal storage conditions without specific inconsistencies. Store in dry places between 20 ° C

and 35 ° C. Recommended storage is in a glass container. Incompatible with an iron container.
